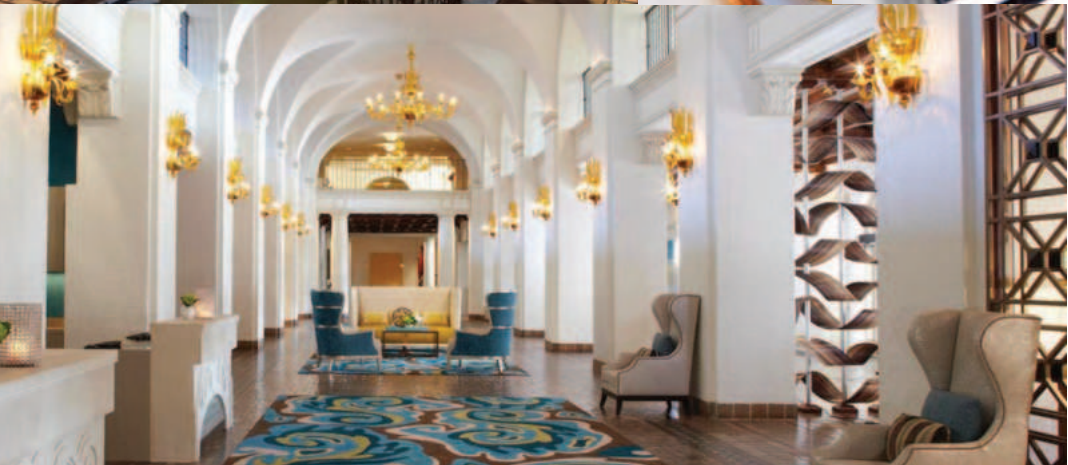

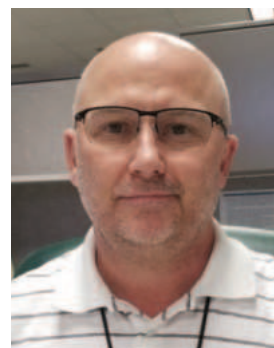
ROBERT JESSEE, JR.
